A NOTE FROM NEMONT'S CEO, MIKE KILGORE

Also on the topic of change, I'd like to share important news:

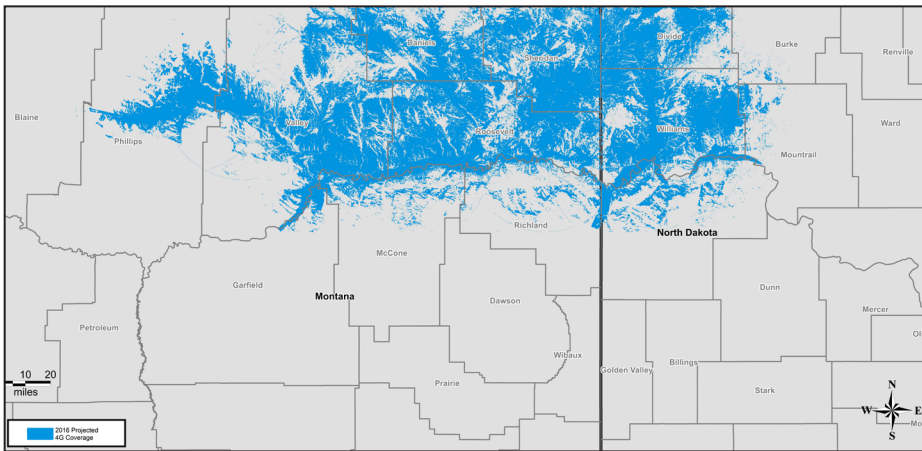
Nemont has launched a Fiber to the Home project (FTTH) in Hinsdale! It's now in its preliminary phase as we seek to acquire right of way in hopes of beginning construction this summer. Nemont crews were recently in the area performing site surveys, which are needed when fiber is installed. Many subscribers in rural settings are not able to receive the benefits of a large and reliable bandwidth connection, due to older copper networks and their distance limitations. When fiber is installed in Hinsdale, customers will experience more reliable voice services as well as access to higher Internet speeds and our video services.

In 1996, the Universal Service Fund (USF) was created to help companies like Nemont provide essential and affordable telecommunication services in high-cost rural areas that are comparable to those offered in urban areas. The original intent of USF was to provide support to rural companies to aid in the deployment and maintenance of plain old telephone service, but we now live in a world that demands high-speed Internet and mobility. **The FCC has been working to transform the USF to support today's relevant and in-demand services.**

In 2011, the FCC released its first comprehensive USF reform order with the goal of modernizing the universal service and intercarrier compensation systems. (Inter-carrier compensation refers to the charges that other telecommunications providers pay Nemont for the use of our network.) The changes are supposed to ensure that robust, affordable voice and broadband service, both fixed and mobile, are available to Americans across the nation.

NOT SO FAST 3G... 4G IS COMING!

Nemont's teams have been busy installing new 4G sites in NE Montana and NW North Dakota over the past year or so as part of our long-term goal to expand the network to match our existing 3G coverage. 4G provides a number of benefits over the old 3G network including expanded roaming with our Canadian neighbors and much faster mobile data speeds. We've delayed our 4G product launch until the summer of 2016 to allow enough time to continue installing new 4G equipment to expand our coverage. After all, it's most important that you can continue to make phone calls from areas where your 3G phone works today. Expanding the 4G network to match the existing 3G coverage has been one of our primary objectives. This may be why you've spotted some new equipment on our cell towers that hasn't begun improving your service quite yet.

The 4G network will work like the 3G service, except with a substantial improvement in your mobile data speeds! The 4G service will also provide excellent voice and data coverage in areas like Opheim, Medicine Lake, Froid and all along Hwy 2. We pride ourselves on serving our friends and neighbors in these communities that the "big national carriers" have never served or even heard of. Our five local Nemont sales offices are staffed with our best and brightest to help answer any of your 4G coverage or feature questions. They're backed by our own local engineers and technicians who strive to provide the best possible service to our customers.

We hope you'll give our new 4G service a try later this summer. Thanks so much for entrusting us with your telecommunications service. Nemont takes great pride in building wireless networks where no other national carrier has gone — this place we're proud to call home.

Why are we so concerned with the FCC's actions? **The funding Nemont receives from the USF, combined with intercarrier compensation, comprises over 50 percent of our total revenue.** It's because of these systems that we're able to transform our network to the modern broadband network needed today and tomorrow.

In 2015, the FCC released its latest order on USF reform. To comply with the significant changes to the USF rules governing small rural carriers such as Nemont, we'll need to make a difficult choice from two options. The first is a regulatory system where we receive USF support via a cost model based on a fictitious network design. One drawback is that while we'll know our payments for the next 10 years, there is no certainty as to what happens after that 10-year period. The second option is to stay within the existing cost-based rate of return regulations. However, the rate of return that may be earned on the regulated interstate services will be reduced from 11.25 percent to 9.75 percent over a six-year period and "stand-alone" broadband (the purchase of broadband without voice service) will be supported under a transformed USF mechanism involving 11 convoluted steps to come up with the new supported amount.

Nemont's commitment to provide high-quality, advanced, and competitive communications services in rural communities remains steadfast. We're working diligently to analyze the potential impact of each option. One thing we know for certain is that the future of USF continues to be uncertain!

NEMONT NAMED CERTIFIED GIG-CAPABLE PROVIDER

Nemont was recently recognized as a Certified Gig-Capable Provider by NTCA—The Rural Broadband Association for delivering gigabit broadband speeds and enabling technological innovation in the Scobey/Scobey Rural communities. NTCA is the premier association representing nearly 900 independent, community-based telecommunications companies that are leading progress in rural and small-town America.

As a Certified Gig-Capable Provider, Nemont joins a national campaign to build awareness and industry recognition of community-based telecom providers that have built communications networks capable of delivering Internet speeds of up to one gigabit per second. Nemont also received tools to promote itself as a Gig-Capable Provider in the Scobey/Scobey Rural communities and will be recognized in NTCA media, on the NTCA website, and during association conferences and events.

"I applaud Nemont for its commitment to delivering the Internet's fastest speeds—an accomplishment worthy of much praise considering the unique and challenging circumstances small, community-based telecommunications providers operate under every day in serving some of our country's most rural and remote communities," said NTCA Chief Executive Officer Shirley Bloomfield. "By building a gigabit-capable network, Nemont has not only overcome these challenges, but also shattered conventional benchmarks for broadband speed to enable cutting-edge technologies that drive innovation and

promote economic development in their communities, region and nationwide."

Mike Kilgore, Chief Executive Officer of Nemont, noted, "Nemont is proud to offer gigabit services because high-speed Internet creates endless possibilities in a connected world. Existing businesses can grow, new businesses can be established in rural areas, schools can develop one-on-one initiatives, telemedicine can be offered in rural communities, and communities can enhance their economic development. With these faster Internet speeds, our rural lifestyle will be enhanced without having to sacrifice access to services that have previously only been offered in urban areas."

To achieve certification, telecommunications companies must show that gigabit technology is currently commercially available within 95 percent of one or more exchanges within its serving territory and that such service can be provided without new trenching or stringing new aerial facilities. This statement must be confirmed by a letter from an engineering firm or other independent source involved in the company's network planning, deployment or operation.

HOW FAST IS A GIG INTERNET CONNECTION?

You've probably heard people mention Gig Internet speeds in the last few years, but like many, you may be unclear on exactly what the term means. Just how fast is a Gig?

A Gig means 1 Gbps (Gigabit per second). It's the equivalent of 1,000 Mbps (Megabits per second), which is over 100 times faster than the average high-speed Internet connection in the U.S. of 10 Mbps.

Take a look at this comparison of how much faster you can complete online activities with a 1 Gbps connection versus a 10 Mbps connection:

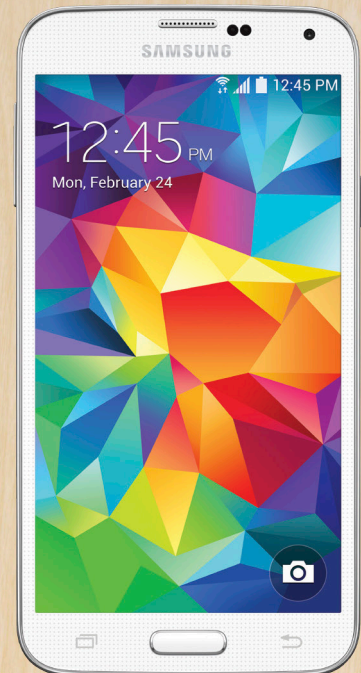
Application	10 Mbps Connection	1 Gbps Connection
Download HD movie	Over an hour and a half	Less than one minute
Download 100 digital pictures	Five minutes	Three seconds
Stream multiple movies and/or TV shows	Maxes out at only two HD shows	Capable of streaming 200 HD shows at one time
Download 20GB video game	Almost five hours	Less than three minutes
Download 100 digital music files	Five minutes and 20 seconds	Less than four seconds

In addition to these incredibly fast download times, a 1 Gbps connection also provides households with enhanced Internet performance and enjoyment. For example, gamers are able to seamlessly play online games with real-time video content and 3D responsiveness. And video quality is greatly improved during video conferencing with Skype or other services.

In the business world, Gig speeds are a huge timesaver and productivity booster. Employees can do whatever they're doing now — data transferring, downloading and uploading — but it will get done in seconds instead of minutes, or minutes instead of hours. Gig speeds also open the door to the optimal use of real-time collaboration tools and cloud-based applications.

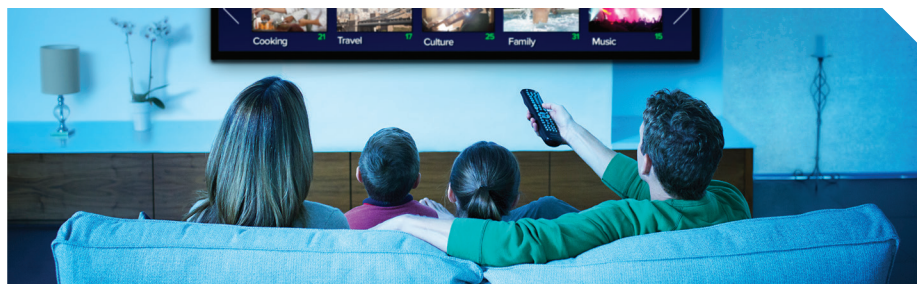
